

MINUTES OF A SPECIAL SESSION OF THE MARCELINE CITY COUNCIL
December 6, 2022

The Marceline City Council met in regular session on December 6, 2022, at 5:30 p.m. in the Council Chamber of Marceline City Hall, Mayor Sallie Buck presiding. Council members present were Josh Shoemaker Gary Carlson, Tracy Carlson, and Brian Baker. Staff attending: City Manager Richard Hoon and City Clerk Lindsay Krumpelman. Others Present: Dave Tavres (DM Ex. Dir), Reporter Angie Hutschreider, and Applicants Shelly Milford, Nathan Cook, Karie Mast and Kalye Lichtenberg.

Mayor Buck led the assembly in the Pledge of Allegiance and called the meeting to order at 5:30 pm.

NEW BUSINESS:

New Council Person Discussion / Interview / Selection: Mayor Buck stated they will meet with each individual applicant and stated there is a list of questions to ask each applicant. They went over the selection procedure. The Council discussed the applicants. As each applicant arrived the Mayor went over the process with them. The Council interviewed each candidate. The candidates arrived and departed as follows:

1. Applicant Shelly Milford met with the Council from 5:36 pm to 5:48 pm and then joined the audience.
2. Applicant Nathan Cook met with the Council from 5:58 pm to 6:13 pm and then left the meeting.
3. Applicant Karie Mast met with the Council from 6:18 pm to 6:30 pm and then left the meeting.
4. Applicant Kalye Lichtenberg met with the Council from 6:37 pm to 6:50 pm and then left the meeting.

During the time between the candidate interviews, the Council and audience talked of non-city business items. After the last interview, Councilman Shoemaker stated he appreciated all the applicants for applying for the position. The Council members filled out individual ballots to select their favorite applicant. Three (3) ballots were for Shelly Milford, one (1) was for Nathan Cook and one (1) was for Kalye Lichtenberg. Councilman Baker moved to appoint Shelly Milford to fill Councilman Tracy Carlson's soon to be vacated seat until the April 2023 election. Councilman T. Carlson seconded the motion. The following roll call carried the motion: Councilman Baker – aye, Councilman T. Carlson – aye, Councilman G. Carlson – aye, Councilman Shoemaker – aye, and Mayor Buck – aye. The Council congratulated Shelly Milford and welcomed her. Councilman T. Carlson stated with her appointment he is officially resigned from the Council after this meeting. City Clerk Krumpelman stated Councilwoman-select Shelly Millford will take the Oath of Office at the City Council's December 14th regular meeting. Councilman Shoemaker moved to adjourn. Councilman T. Carlson seconded the motion. The motion carried and the meeting adjourned at 6:57 pm.
